Course Description

Explores what is meant by participation and how institutions can favor (or not) greater involvement of individuals in the relevant political processes. First, it explains what we mean by participation, a multidimensional concept, and discusses the reasons why citizens decide (or not) to participate and in what capacity. Secondly, it delves into the instruments, mechanisms, and evaluation of citizen participation, its limits and consequences, as well as the incorporation of citizen participation in the coproduction of public policies. In a broader lens, we will investigate the current crisis of global democracy, the rise of populism, and efforts to rebuild democracy from the local and global level.

Course Requirements

Please view the videos for each session (2 per day) and do the readings prior to class.

For students participating in the course for academic credit, student evaluation would be based on: (a) participation in class discussion (20%); (b) short in-class presentation on further reading (10%); (c) short in-class presentation on a democratic action or organization; and (d) a final 3-page paper or final exam (60%).

The final paper is due July 14 at 4.00pm. The final paper is to apply concepts learned in the course to analysis of contemporary problems in democratic participation. To this end,

students will be asked to write a 2500-word policy brief addressed to a government official or non-governmental organisation outlining how to approach a specific problem in democratic participation.

The final online exam will be held on July 14 from 3.00pm-4.30pm. The exam will feature open-ended questions designed to elicit critique and synthesis of arguments encountered in the course.
